## CREDIT REQUIREMENTS

<p><b>Qualifying Credit Score:</b></p>	<ul style="list-style-type: none"> <li>• Primary wage earner must have at least 2 scores and is used to determine the overall loan qualifying credit score.             <ul style="list-style-type: none"> <li>✓ If three scores are provided, use middle score</li> <li>✓ If two scores are provided, use lowest score</li> <li>✓ If one score is provided, the borrower is not eligible</li> </ul> </li> <li>• Each additional borrower must have at least one score.             <ul style="list-style-type: none"> <li>✓ If three scores are provided, at least one must be 620+</li> <li>✓ If two scores are provided, at least one must be 620+</li> <li>✓ If one score is provided, it must be 620+</li> </ul> </li> <li>• When qualifying income is equal for all borrowers the highest representative score is used to determine the loan qualifying score.</li> <li>• When the transaction includes a non-occupying coborrower the qual score of the occupying borrower is used.</li> <li>• For Asset Depletion doc type, the lowest overall borrower representative score is used to determine the loan qualifying score.</li> </ul>
<p><b>Tradelines:</b></p>	<ul style="list-style-type: none"> <li>• Tradeline requirement based on primary wage earner.</li> <li>• Borrowers with 3 credit scores:             <ul style="list-style-type: none"> <li>✓ No minimum tradelines required</li> </ul> </li> <li>• Borrowers with 2 credit scores:             <ul style="list-style-type: none"> <li>✓ 3 tradelines reporting for 12+ months with activity in the last 12 months; OR</li> <li>✓ 2 tradelines reporting for 24+ months with activity in the last 12 months; OR</li> <li>✓ 1 mortgage or installment tradeline reporting for 36+ months with activity in the last 12 months .</li> </ul> </li> <li>• To qualify as a valid tradeline, the following requirements apply:             <ul style="list-style-type: none"> <li>✓ Must be reflected on credit report. (An acceptable 12- or 24-month housing history, not reporting on credit, may also be used as a tradeline.)</li> <li>✓ Must have activity in the past 12 months and may be open or closed.</li> <li>✓ Max 0 x 60 x 12.</li> </ul> </li> <li>• Credit lines on which the borrower is not obligated to make payments are not acceptable. Examples include loans in a deferment period, collection or charged-off accounts, accounts discharged through bankruptcy, and authorized user accounts.</li> <li>• Student loans can be counted as tradelines if they are in repayment and are not deferred.</li> <li>• Insufficient tradelines and non-traditional credit is not allowed. Each borrower must have a valid and usable score.</li> </ul>
<p><b>Housing Events:</b></p>	<ul style="list-style-type: none"> <li>• A Housing Event is any one of the following events listed below:             <ul style="list-style-type: none"> <li>✓ Foreclosure, Deed-in-Lieu, or Short Sale measured from the date of completed sale or final property transfer. The Housing Event must be completed prior to loan closing with no outstanding deficiency balance remaining.</li> <li>✓ 1x120 mortgage late measured from the date the mortgage was brought current.</li> <li>✓ Modification measured from the date the modification was executed which resulted in:                 <ul style="list-style-type: none"> <li>• Forgiveness of a portion of principal and/or interest on either the first or second mortgage.</li> <li>• Application of a principal curtailment by or on behalf of the investor to simulate principal forgiveness.</li> <li>• Conversion of any portion of the original mortgage debt to a “soft” subordinate mortgage.</li> <li>• Conversion of any portion of the original mortgage debt from secured to unsecured.</li> </ul> </li> </ul> </li> <li>• If the property was surrendered in a Chapter 7 bankruptcy, the bankruptcy discharge date is used for seasoning. Bankruptcy papers may be required to show the property was surrendered. The foreclosure action is not required to be fully complete.</li> </ul>

## CREDIT REQUIREMENTS (continued)

<b>Housing History:</b>	<ul style="list-style-type: none"> <li>• A 12-month mortgage history is required for all financed properties owned by the borrower.</li> <li>• A 12-month rental history is required when the borrower is renting their current primary residence.</li> <li>• Institutional housing payments not reflected on the credit report may be documented as follows: <ul style="list-style-type: none"> <li>✓ Verification of Rent (VOR) or Verification of Mortgage (VOM) for m; OR</li> <li>✓ Lender generated payment history showing paid dates and due dates; OR</li> <li>✓ Mortgage statements for the review period if they indicate the due date which each payment was applied to; OR</li> <li>✓ Credit supplement through the same credit reporting agency as the original credit report.</li> </ul> </li> <li>• Non-Institutional housing payments not reflected on the credit report may be documented as follows: <ul style="list-style-type: none"> <li>✓ Verification of Rent (VOR) or Verification of Mortgage (VOM) for m; OR</li> <li>✓ Lender generated payment history showing paid dates and due dates; OR</li> <li>✓ Mortgage statements for the review period if they indicate the due date which each payment was applied to; OR</li> <li>✓ Credit supplement through the same credit reporting agency as the original credit report; AND</li> <li>✓ Most recent 12 months cancelled checks or bank statements. (Note, these must be accompanied with one of the items listed above they are not sufficient alone.)</li> </ul> </li> <li>• A combined total of all late mortgage and rental payments in the past 12 months must be used to determine the housing history.</li> <li>• All mortgages and rental payments should be current at time of closing. If the credit report or VOR/VOM reflects a past-due status, updated documentation is required to verify account is current.</li> <li>• All mortgages being paid off in a refinance or new-construction purchase transaction must have a verified, monthly payment history. All of the following requirements must be met:                                 <ul style="list-style-type: none"> <li>▪ A copy of the repayment agreement is obtained,</li> <li>▪ A minimum of 3 months has elapsed on the plan,</li> <li>▪ Evidence of timely payments for the most recent 3 months is provided, and</li> <li>▪ The maximum payment required under the plan is included in the DTI.</li> </ul> </li> </ul> </li> <li>• Outstanding state and federal tax liens or delinquent obligations may remain open on purchase transactions only (additional LTV reductions may be required based on the size of the lien).
