<p><b>Qualifying Credit Score:</b></p>	<ul style="list-style-type: none"> <li>• A credit report must be obtained for all borrowers who have a valid Social Security Number.</li> <li>• Each individual borrower’s qualification score is determined as follows:             <ul style="list-style-type: none"> <li>✓ 3 scores: Middle score</li> <li>✓ 2 scores: Lowest score</li> <li>✓ 1 score: Borrower is not eligible</li> </ul> </li> <li>• Lowest qualification score of all borrowers is used for overall loan qualification.</li> </ul>
<p><b>Tradelines:</b></p>	<p><b>Non-Foreign National:</b></p> <ul style="list-style-type: none"> <li>• All borrowers must be evaluated individually.</li> <li>• Borrowers with 3 credit scores:             <ul style="list-style-type: none"> <li>✓ No minimum tradelines required</li> </ul> </li> <li>• Borrowers with 2 credit scores:             <ul style="list-style-type: none"> <li>✓ 3 tradelines reporting for 12+ months all with activity in the last 12 months; OR</li> <li>✓ 2 tradelines reporting for 24+ months all with activity in the last 12 months.</li> </ul> </li> <li>• To qualify as a valid tradeline, the following requirements apply:             <ul style="list-style-type: none"> <li>✓ Must be reflected on credit report. <p><b>Housing History:</b></p>	<ul style="list-style-type: none"> <li>• A 12-month history is required for borrower's primary residence if in United States, and subject property if a refinance transaction.</li> <li>• A housing history is not required for other REO not reporting on credit.</li> <li>• Any housing event reported on credit for any property must be included in housing history eligibility.</li> <li>• Institutional housing payments not reflected on the credit report may be documented as follows:             <ul style="list-style-type: none"> <li>✓ Verification of Rent (VOR) or Verification of Mortgage (VOM) form; OR</li> <li>✓ Lender generated payment history showing paid dates and due dates; OR</li> <li>✓ Mortgage statements for the review period if they indicate the due date which each payment was applied to; OR</li> <li>✓ Credit supplement through the same credit reporting agency as the original credit report.</li> </ul> </li> <li>• Non-Institutional housing payments not reflected on the credit report may be documented as follows:             <ul style="list-style-type: none"> <li>✓ Verification of Rent (VOR) or Verification of Mortgage (VOM) form; OR</li> <li>✓ Lender generated payment history showing paid dates and due dates; OR</li> <li>✓ Mortgage statements for the review period if they indicate the due date which each payment was applied to; OR</li> <li>✓ Credit supplement through the same credit reporting agency as the original credit report; AND</li> <li>✓ Most recent 12 months cancelled checks or bank statements. <b>ITIN:</b>	<ul style="list-style-type: none"> <li>Individual Taxpayer Identification Number (ITIN) borrowers are individuals with an ITIN who reside and work within the United States but do not possess U.S. citizenship.</li> <li>The following documentation is required for all ITIN borrowers:                             <ul style="list-style-type: none"> <li>✓ ITIN card or letter from IRS assigning the ITIN number to the borrower.</li> <li>✓ Unexpired government photo ID (driver's license, passport, visa, etc.)</li> </ul> </li> </ul>			

**BORROWERS** (continued)

**Perm Resident Alien:**

- A permanent resident alien is a non-U.S. citizen authorized to live and work in the U.S. on a permanent basis. Permanent resident aliens are eligible for financing.
- Acceptable evidence of lawful permanent residency must be documented and meet one of the following criteria:
  - ✓ I-151 – Permanent Resident Card (Green Card) that does not have an expiration date
  - ✓ I-551 – Permanent Resident Card (Green Card) issued for 10 years that has not expired
  - ✓ I-551 – Conditional Permanent Resident Card (Green Card) issued for 2 years that has an expiration date and is accompanied by a copy of USCIS Form I-751 requesting removal of the conditions
  - ✓ Un-expired Foreign Passport with an un-expired stamp reading as follows: “Processed for I-551 Temporary Evidence of Lawful Admission for Permanent Residence. Valid until mm-dd-yyyy. Employment Authorized.”

**Non-Perm Resident Alien:**

- Lawful non-permanent residents are legally accorded the privilege of residing temporarily in the United States.
- 2 years US residency history required, with valid Social Security Number and US credit.
- Validation that borrower has employment authorization is required with **one** of the following:
  - ✓ Valid, current EAD work permit/card (Form I-766 Employment Authorization Document). The EAD may not expire within 6 months of application date.
  - ✓ Form I-765 Application for Employment Authorization. The form must reflect approval status in the Action Block (upper right-hand corner)
  - ✓ Form I-797, I-797A, or I-797B or I-797C conveying approval status.
  - ✓ Valid, current Visa permitting employment authorization. The following VISA types are acceptable: E-1, E-2, E-3, G-1 through G-5, H-1B, L-1A, L-1B, O-1, R-1. Other VISA types permitting employment may be considered, see the U.S. Dept of State Website at Directory of Visa Categories (state.gov).
- For residents of Canada or Mexico, H-1B status stamped on an unexpired passport is acceptable documentation.
- Copy of borrower’s passport is not required.

**Asylum:**

- Individuals granted asylum are eligible for financing.
- 2 years US residency history required, with valid Social Security Number and US credit.
- Validation that borrower has employment authorization is required with **one** of the following:
  - ✓ Valid, current EAD work permit/card (Form I-766 Employment Authorization Document) referencing code C08. The EAD may not expire within 6 months of application date.
  - ✓ Form I-94 with a stamp or notation, such as “asylum granted indefinitely” or the appropriate provision of law (8 CFR 274a.12(a)(5) or INA 208) to show their employment authorization. The asylee does not need to present a foreign passport with this Form I-94. An asylee can also present an electronic Form I-94 with an admission class of “AY.”
- Copy of borrower’s passport is not required.

<b>DACA:</b>	<ul style="list-style-type: none"> <li>• Individuals who can provide documentation of current DACA status along with work authorization are eligible for financing under the same criteria as a non-permanent resident.</li> <li>• 2 years US residency history required, with valid Social Security Number and US credit.</li> <li>• Validation that borrower has employment authorization is required with one of the following:             <ul style="list-style-type: none"> <li>✓ Valid, current EAD work permit/card (Form I-766 Employment Authorization Document) referencing code C33. The EAD may not expire within 6 months of application date.</li> <li>✓ Form I-797 conveying approval status for Case Type I765-Application for Employment Authorization referencing code C33.</li> <li>✓ Form I-765 Application for Employment Authorization, the form must reflect approval status in the Action Block (upper right-hand corner of the form) Copy of borrower's passport is not required.</li> </ul> </li> </ul>
<b>Foreign National:</b>	<ul style="list-style-type: none"> <li>• A Foreign National is a non-resident alien who is not authorized to live or work in the U.S.</li> <li>• A Foreign National may periodically visit the U.S. for various reasons including vacation and/or business, however, they must live in another country. This must be evidenced on URLA Page 1 Current Address.</li> <li>• Borrower must provide a third-party document with an address that matches the primary residence on the application e.g., lease agreement, utility bill, financial statement.</li> <li>• A US Mailing address is required. Once obtained, ACC to update URLA Page 1 Mailing Address.</li> <li>• Automatic Payment Authorization (ACH) is required from a US checking account and will be arranged through closing on ACC's form.</li> <li>• Florida Foreign Interest Affidavit is required at closing for subject properties located in the state of Florida.</li> <li>• Copy of the borrower's foreign issued passport must be obtained.</li> <li>• Visa is not required.</li> </ul>

<b>Asset Verification:</b>	<ul style="list-style-type: none"> <li>• Assets must be seasoned for 30 days or sourced.</li> <li>• Assets must be verified with one of the following:             <ul style="list-style-type: none"> <li>✓ Account statements for the most recent month or quarter indicating opening and closing balances.</li> <li>✓ Written Verification of Deposit (VOD) completed by the financial institution.</li> <li>✓ Statements provided by third-party asset verification companies (e.g., AccountChek, Finicity, Plaid) if the vendor participates in FNMA Day 1 Certainty.</li> </ul> </li> </ul>
<b>Large Deposits:</b>	<ul style="list-style-type: none"> <li>• Generally, not sourced.</li> <li>• Sourcing may be necessary in some situations. Examples can include but are not limited to completing a full-30 days of asset verification for funds to close when moved from foreign accounts or documenting the minimum borrower contribution has been met from borrower's own funds.</li> </ul>
